Dear Leader Schumer, Speaker Pelosi, Leader McConnell, and Leader McCarthy,

We write to respectfully request that the conference preserve Section 71106, “Leasing on the Outer Continental Shelf,” of the *America COMPETES Act of 2022* during the upcoming bicameral conference negotiations for the *Bipartisan Innovation Act*. This provision will lift the arbitrary and overly-broad ban on new leases for offshore wind in the South Atlantic and Eastern Gulf of Mexico, a crucial step towards improving America’s energy independence and global competitiveness.

In September 2020, President Trump withdrew areas off the coasts of North Carolina, South Carolina, Georgia, and Florida from new offshore oil and gas leasing in a pair of memoranda for the Secretary of the Interior dated September 8 and September 25, 2020.<sup>1</sup> Due to the broad and imprecise language of these memoranda, the 10-year moratorium also applies to offshore wind. This offshore wind moratorium imperils a critical new wave of offshore wind energy development, threatens tens of thousands of high-quality jobs in a globally competitive industry, and wastes billions of dollars of investments planned or already in-progress for offshore wind projects. Projects of this sort are critical to fulfilling President Biden’s promise to deploy 30 gigawatts of offshore wind in the United States by 2030, and to compete with China’s rapidly expanding offshore wind industry.

Section 71106 would overturn this arbitrary offshore wind leasing ban to enable those in North and South Carolina, Georgia, and Florida—states that are home to some of the highest offshore wind energy capacity potentials in the country—to advance offshore wind projects along the coastline. This critical provision would jumpstart clean energy development at a time when it is needed most, and ensure that these states are free to be a part of this competitive new industry.

This provision has been endorsed by bipartisan organizations including the U.S. Chamber of Commerce, American Clean Power Association, American Waterways Operators, National Association of

Manufacturers, National Ocean Industries Association, League of Conservation Voters, National Audubon Society, National Wildlife Federation, Natural Resources Defense Council, Oceana, Ocean Conservancy, Southeastern Wind Coalition, and Southern Environmental Law Center.

Overturing this arbitrary ban is critical to the production of clean energy here in the United States, creating high quality jobs, and improving America's competitiveness on the global scale. Accordingly, we urge you to ensure that this provision remains in the legislation.


